

TO WHOM IT MAY CONCERN:

12/11/25

My NAME IS SHANE POLLARD #1487792. I AM CURRENTLY BEING HOUSED AT RED OXION STATE PRISON (R.O.S.P) FOR A MINOR 200 (239a) OFFENSE CODE. I WAS EMERGENCY TRANSFERRED FROM KEEN MOUNTAIN CORRECTIONAL CENTER (KMCC) AS A LOW Level 4 WITH 26 POINTS. I BELIEVE I'M A LEVEL 3 INMATE AT THIS CURRENT MOMENT. THE TRANSFER OCCURRED THAT SAME DAY AS THE INCIDENT (10/31/25) ABOUT 4-5 HOURS AFTER THE EVENTS. I WAS ASSAULTED/ATTACKED BY FIVE OFFICERS AND A K9 ATTACK DOG. I WAS "OC SPRAYED" NOT ONCE BUT TWICE. I WAS STRUCK BY OFFICERS CLOSED FIST MULTIPLE TIMES. I SUFFERED SEVERE DAMAGE TO MY LEFT HAND FROM THE K9 ATTACK AS WELL AS MY RIGHT FOREARM. I SUFFERED BRUISING AND A SEVERE LACERATION TO MY UPPER LIP, AND A LOOSE FRONT TOOTH FROM THE OFFICERS ASSAULT. I WAS TRANSFERRED TO R.O.S.P AND PUT IN A STRIP CELL WITH NO BLANKET, NO MATTRESS OR ANY CLOTHING ITEMS ISSUED TO ME. I WENT ON A HUNGER STRIKE TWICE FOR 4 DAYS EACH BECAUSE THEY WOULD NOT ISSUE ME ANYTHING UNTIL 14 DAYS HERE. THE REASON I STARTED THE 2ND HUNGER STRIKE IS BECAUSE THEY BROUGHT ME A RIPPED UP STINKING AND ODOR SMELLING MATTRESS, A HALF OF BLANKET, USED CLOTHING SUCH AS ANOTHER MANS DIRTY TIGHTY WHITIES UNDERWEAR. THEY ISSUED ME NO HYGIENE ITEMS AS WELL. MIND YOU I'M A NEW INTAKE INTO THIS FACILITY. R.O.S.P HAVE TAKEN MY VIDEO VISITS FROM A CHARGE I HAD AT KMCC ON 9/16/25. MIND YOU THAT CHARGE WAS DISMISSED ON APPEAL 10/31/25 BY THE WARDEN OF KMCC. SO I'VE HAD NO CONVICTIONS FOR THEM TO TAKE THEM. THAT WASN'T EVEN MY PENALTY OR SANCTION FOR THE CHARGE. I HAVE NO CHARGES FOR THIS FACILITY, YET THEY'RE PUNISHING ME. THE 200 CHARGE THAT THEY (KMCC) TRANSFERRED ME FOR WAS NOT HEARD WITHIN 30 DAYS OF ME BEING HERE. THEY GAVE ME A "NOTICE OF AUTHORIZED CONTINUANCE" ON 12/5/25 SAYING "OFFENDER UNAVAILABLE DUE TO MEDICAL REASON". I'VE NEVER BEEN HOSPITALIZED OR UNDER ANY MEDICAL CARE, SO THAT'S A LIE. IF KMCC HEARD ANY CHARGES FOR THE MONTH OF NOVEMBER, THEN WHY DIDN'T THEY HEAR MINE? BUT ALLOW ME TO EXPLAIN EACH PROCESS

And what occurred from the beginning causing the chain of events up until TODAY....

- On 9/16/25 @ 9:33am, I filed a P.R.E.A complaint against officer Sentiger (KMCL).
- On 9/16/25 @ 9:44am, just 10 minutes after my complaint I had a charge written against me for "unauthorized use of the P.R.E.A Hotline."
- On 9/24/25, The Hearing officer of KMCL found me guilty of using the Hotline. This is the charge that was overturned on Appeal by warden of KMCL on 10/31/25 but yet R.O.S.P is using this to take my visits. KMCL didnt even take my visits and it really doesnt matter cause it was overturned on Appeal.
- On 10/16/25 - I was strip searched in front of T-6 officers in G.P for no other reason but to harass and intimidate me. This is officer Sentiger shift. He was floor officer all day until I got strip searched. I believe he sent his buddies to strip search me. Anyway I wrote it up.
- On 10/22/25 @ 2:20pm, officer Sentiger came to my cell door (A340 KMCL) harassing and antagonizing me about my P.R.E.A complaint against him and said "Guess that didnt go in your favor huh, ATIA, try again big daddy." I wrote a complaint about it asking them to keep him away from me and that I do not feel safe. Please transfer me to a lateral level 4 or something.
- On 10/31/25, officer Sentiger told me to step out into the hallway to talk to him. I told him "NO, I DONT WANT TO TALK TO YOU, There is nothing to talk about. I have placed multiple complaints against you and you still been harassing and antagonizing me." I told the Booth officer Cook that I do not wish to talk to officer Sentiger, I have placed multiple complaints on him and I do not feel safe talking to him alone. The booth officer said that he understood and just wait for officer Keene to come up and go talk to them. WHEN officer Keene arrived, he and officer Sentiger exchanged words then they told me step out. I again refused and said ITS NOTHING to talk about. If you all want to lock me up then do it right here right now but Im not stepping in the hallway. officer Keene said "NO we not locking you up, just step out so we can talk.. After a little hesitation on reluctance and a gut feeling telling me dont step out, I step into the foyer. I am immediately surrounded

by five officers and a K9 dog. At this time I just knew that AIN'T NOTHING GOOD ABOUT TO COME OUT OF THIS. So I just back myself into a corner and put my back against the wall. It's officer Sentiger, officer Keene, officer Ball, Sgt. Wade and K9 officer FANNIN with his K9 "CLETUS". They immediately start telling me to turn around AND PLACE MY HANDS BEHIND MY BACK. I ASK "FOR WHAT, WHAT I DO?". They say TURN AROUND AND PUT YOUR HANDS BEHIND YOUR BACK. I JUST STOOD THERE, ^{QUIET.} ~~BEHIND.~~ Officer BALL begins spraying me with 'OC spray'. I wipe my face and still just stood there. Officer BALL sprays me again. I still just stood there trying to WIPE MY FACE. AT THIS TIME I CAN'T SEE AND MY EYES AND FACE ARE BURNING. I BEGAN TO FEEL OFFICERS GRAB, TUG, PULL AND TWIST MY ARMS TO GET THEM BEHIND MY BACK. AT THIS POINT I BEGAN RESISTING BY SNATCHING MY ARMS CONSTANTLY AWAY. THEY SAY I THREW A PUNCH. I COULDN'T SEE. IT ALL HAPPENED IN A BLUR. BUT NEXT THING I KNOW, I'M BEING STRUCK IN THE FACE, HEAD AND NECK AREA. I JUST CURL UP AND TRY TO BLOCK THE STRIKES AS BEST AS I COULD. WHILE THEY WERE STRIKING ME THE K9 OFFICER FANNIN tells them to back away hes releasing the K9. He releases the K9 and IT BITES DOWN ON MY LEFT HAND LEAVING SEVERE DEEP WOUNDS AND DAMAGE TO MY HAND. THE PAIN IS UNBEARABLE SO I BEGAN RESISTING THE DOG. THEY SAY I STRUCK THE DOG. IN THAT PROCESS IT LETS GO OF MY LEFT HAND BUT IMMEDIATELY BITES DOWN ON MY RIGHT FOREARM LEAVING DAMAGES AS WELL. I AM EVENTUALLY DRAGGED TO THE GROUND AND I ASK THEM TO GET THE DOG OFF ME. THEY HANDCUFF ME AND TAKE ME TO THE HOLE. THEY DON'T GIVE ME NO DECONTAMINATION SHOWER BUT THEY PLACE ME IN A STRIP CELL, PUT ME IN A TURTLE SUIT AND SHACKLE MY HANDCUFFS AND LEG SHACKLES TOGETHER. MEDICAL COMES CLEAN THE WOUND AND WRAP IT UP. THEY EMERGENCY TRANSFER ME TO R.O.S.P THAT SAME DAY. I GET TO THIS FACILITY AT ABOUT 2PM. THEY ISSUE ME NOTHING. THEY STICK ME IN ANOTHER STRIP CELL WITH NOTHING. AT THIS POINT I BEGAN A HUNGER STRIKE THAT DAY STARTING AT DINNER BECAUSE THEY HAVEN'T ISSUED ME ANYTHING. I DIDN'T SHOWER UNTIL 3 DAYS LATER. I HAD ALL THE SAME BLOODY CLOTHES ON MY BACK THAT I USE TO DRY OFF FROM THE SHOWER UNTIL 11/6/25 WHEN AN OFFICER BROUGHT ME USED CLOTHES, DIRTY TIGHTY WHITERS. I IMMEDIATELY GO BACK ON HUNGER STRIKE 11/10/25 BECAUSE NOW YOU ALL JUST GIVING ME ANYTHING TO GET ME TO STOP THE

Hunger strike. I don't get what I need until 11/14. ON 12/2/25, I.C.A. for Red Onion recommended me Security Level "S". I HAVE a 200 minor offense charge. I HAVE never had any violent offense charges on my disciplinary record at all. My charge wasn't even heard within 30 days to hear the charge but they somehow gave me a new Hearing date for 12/10/25. How can I.C.A. recommend Level "S" for me when the charge was suppose to be vacated after the 30 day deadline and since my new Hearing date is 12/10/25 y'all already made a decision to make me Level S without ~~even~~ ^{even knowing} the outcome of the charge. I feel they have violated my 1st amendment right by taking my video visits and restricting my calls to two phone calls a month when I haven't even been found guilty of anything. I feel they have violated my 4th amendment right for strip searching me. What was the reason for it. I was sleep in my cell and they woke me up to do that. I feel they have violated my 8th amendment right for OC spraying me for no reason, Assaulting me and unleashing an attack dog on me. (The police investigator from the street said he ^{investigating} ~~investigating~~ the use of excessive force against me but also assault on law enforcement. I declined to write a statement.) I feel I've BEEN RETALIATED AGAINST at KMCC for using the grievance system. I feel I'm being retaliated against at R.O.S.P for what happened at KMCC and also I'm being retaliated against because I've been using the grievance system upon them now. They wouldn't issue me things for 14 days. I HAD TO go on hunger strike twice to get what I need. They have taken my video visit. They have recommended a Security level "S" which I don't even qualify for or meet the criteria for to be placed on that level. They place me in a cell beside a exit door that constantly slams every 30 min when they do round checks and I've asked to be moved and I've told them it deprives me off sleep. I even wrote that up. I HAVE PTSD, Anxiety and paranoia from these events and I HAVE SPIKED TO MENTAL HEALTH ABOUT it and I'm on wait list to see psychiatrist. Sometimes I don't even eat because I believe they doing things to my food. Especially when I get a different color tray than everyone else. I DON'T know what else to do and I'm looking for ALL the HELP I can get. I HAVE exhausted all my remedies for each event through the grievance system. I pray and hope you can help or point me in the right direction for help, Thank you for your time and Interest in my situation.

It is well appreciated even if its just for an ^{EAR} to hear and observe AND UNDERSTAND

The CONDITIONS Im IN - IF you know any ATTORNEYS that are willing to work on a Contingency base Im willing to offer 33% of the settlement to pursue a lawsuit for Constitutional violations as well as physical, emotionally and mentally damaged. I HAVE all dates, times, complaints, grievances and lately Ive just been waiting for regional administrator response back from appeals of my grievances. Im already involved in a class-action suit with georgetown law civil rights clinic who are ~~pursuing~~ ^{pursuing} a case against the state for an INTUNCTION only against the use of Attack dogs on prisoner. They are trying to get the USE OF ATTACK dogs STOPPED IN virginia Prisons. Please send all correspondences regarding me to the "VADOC Centralized Mail Distribution Center"
